Subject: Intimation of Revised Maximum Retail Prices (MRPs) for Cement Products in the States of North East India pursuant to GST rate reduction effective 22nd September 2025.

Ref: 1. Notification No.I-10/14/2020-W&M dated.09.09.2025 issued by Ministry of Consumer Affairs, Food and Public Distribution Department of Consumer Affairs Weight and Measurement Unit, GOI.

2. Government ease compliance burden on Industry while ensuring benefits of reduced GST for consumers Release ID.2168208 dated.18th September, 2025.

3. GST rate reduction Notification No.09/2025 dated.17.09.2025 issued by Ministry of Finance, Department of Revenue, GOI.

This has reference to the Notification issued by the Department of Consumer Affairs on 09.09.2025 and advisory issued on 18.09.2025, under Rule 33 of the Legal Metrology (Packaged Commodities) Rules, 2011, regarding revision of GST rates.

We, **M/s. GOLDSTONE CEMENTS LIMITED**, is registered under Companies Act, 1956/2013 CIN: U26940ML2007PLC008298 engaged in manufacturing and sale of Cement under GST chapter heading no.2523 in the states of North East India, due to change in GST rate on Cement under HSN code 2523 we have done revision in the Maximum Retail Price (MRP) of our packaged Cement commodities sold in the states of North East India. This revision is undertaken to pass on the full benefit of the reduction in the GST rate on cement from **28% to 18%**, effective **00:00 Hrs on 22nd September 2025**, as recommended by the GST Council.

The revised MRP of Black Tiger Cement for our key products are as follows for the Stats of North East India.
